**[PROPOSED] ORDER GRANTING PLAINTIFFS’  
UNOPPOSED MOTION FOR ATTORNEYS’  
FEES, COSTS, AND INCENTIVE AWARD**

On March 6, 2026, this Court heard Plaintiffs’ Unopposed Motion for Attorneys’ Fees, Costs, and Incentive Award (the “Motion”) filed by Plaintiffs Jeffrey Jacobs and Madeline Casey (“Plaintiffs”). This Court reviewed the Motion and supporting papers. As such, having reviewed the foregoing and based on the findings below, the Court found good cause to grant the unopposed Motion.

The requested attorneys’ fees and costs in the amount of \$1,325,000 is fair and reasonable in light of the nature of this case, Class Counsel’s experience and efforts in prosecuting this Action,<sup>1</sup> and the significant benefit obtained for Class Members. An Incentive Award in the amount of \$7,500 for each Plaintiff is fair and reasonable in light of the risks in commencing this Action, and the time and effort spent litigating this Action as Class Representatives.

1                   **NOW, THEREFORE, IT IS HEREBY ORDERED:**

2                   1.       Class Counsel is awarded attorneys' fees and costs in the total amount of \$1,325,000.  
3 Defendants La-Z-Boy Incorporated and Stitch Industries, Inc. (collectively "Defendant") must pay Class  
4 Counsel within thirty (30) calendar days of the Effective Date and upon receipt of the relevant W-9 Forms,  
5 as set forth in section III.E. of the Settlement Agreement; and

6                   2.       Plaintiffs are awarded an Incentive Award in the amount of \$7,500 each. Defendant must  
7 pay Class Counsel this amount within thirty (30) calendar days of the Effective Date and upon receipt of  
8 the relevant W-9 Forms, as set forth in section III.E. of the Settlement Agreement.

9                   **IT IS SO ORDERED.**
